Vice-chancellor under section 114(1) of the Maharashtra Universities Act, 2016, for the specified period.

Please note that the recognition granted to your college as a recognized ecosystem is valid for one academic year only, i.e., for the academic year 2022-23. It is mandatory for you to renew this recognition periodically.

The local inquiry committee appointed for the natural growth/renewal of sanction for the academic year 2022-23 has mentioned certain terms and conditions in its report. These terms and conditions, as indicated in the attached table, must be fulfilled by your college/accredited institution in accordance with section 108 of the Maharashtra Universities Act 2016. We request you to carefully observe and fulfill the mentioned conditions in their entirety. The compliance report, along with the necessary documents, should be submitted within a period of 3 months. This will facilitate the timely submission of the proposal to the affiliated department of the university for the renewal of affiliation for the academic year 2022-23. It is important to note that if you fail to submit the eligibility report within the specified period, no proposals from your college/recognized institution for the academic year 2019-20 will be accepted, and you will be solely responsible for the consequences.

Colleges that do not fulfill the conditions related to the Principal, Librarian, Director of Physical Education, and 50% of teachers are required to fill these positions within 3 months by submitting a content letter of Rs. 100/- on non-judicial stamp paper for the renewal of affiliation/natural growth for the academic year 2020-21, along with student admissions.

students for the second year. However, these colleges/institutions should pay Rs. 100/- along with relevant documents to demonstrate their efforts in filling the vacant posts.

In cases where related matters of colleges are still pending in court, please be informed that further action will be taken subject to the court's order. Furthermore, please note that NAAC/NBA accreditation will be mandatory for the college.

Sir/Madam,

We acknowledge your request for the approval of the renewal of affiliation/natural growth for the academic year 2022-23, as referenced in letter no. 01. In response to your proposal, a local inquiry committee was appointed by the University, as stated in reference letter no. 02, to conduct an inspection and submit a report regarding your college.

The report submitted by the local inquiry committee was scrutinized through a special committee as per the received order, and the committee's report and recommendations were concluded on 30.06.2016. The decision was then presented for consideration in the Vidya Parishad meeting. Pursuant to the decision, the renewal of affiliation for the subject/course mentioned in the accompanying table, both in terms of Continuation of Affiliation and Natural Growth, has been approved by the Hon. Vice-chancellor under section 114(1) of the Maharashtra Universities Act, 2016, for the specified period.

Please note that the recognition granted to your college as a recognized ecosystem is valid for one academic year only, i.e., for the academic year 2023-24. It is mandatory for you to renew this recognition periodically.

The local inquiry committee appointed for the natural growth/renewal of sanction for the academic year 2023-24 has mentioned certain terms and conditions in its report. These terms and conditions, as indicated in the attached table, must be fulfilled by your college/accredited institution in accordance with section 108 of the Maharashtra Universities Act 2016. We request you to carefully observe and fulfill the mentioned conditions in their entirety. The compliance report, along with the necessary documents, should be submitted within a period of 3 months. This will facilitate the timely submission of the proposal to the affiliated department of the university for the renewal of affiliation for the academic year 2023-24. It is important to note that if you fail to submit the eligibility report within the specified period, no proposals from your college/recognized institution for the academic year 2014-25 will be accepted, and you will be solely responsible for the consequences.



Affiliation Letter for 2023-24

Colleges that do not fulfill the conditions related to the Principal, Librarian, Director of Physical Education, and 50% of teachers are required to fill these positions within 3 months by submitting a content letter of Rs. 100/- on non-judicial stamp paper for the renewal of affiliation/natural growth for the academic year 2024-25, along with student admissions.

Moreover, only the renewal/natural growth of enrolment for the academic year 203-24 will be granted to colleges mentioned as "No admission for first year and/or second year directly" in the accompanying table. Such colleges should not admit students for the first year but may directly admit students for the second year. However, these colleges/institutions should pay Rs. 100/- along with relevant documents to demonstrate their efforts in filling the vacant posts.

In cases where related matters of colleges are still pending in court, please be informed that further action will be taken subject to the court's order. Furthermore, please note that NAAC/NBA accreditation will be mandatory for the college.

In this regard, the government, as per the reference mentioned above (Reference No. 3), has been informed by the Director of Education (Higher Education), Maharashtra State, Pune, that teaching is permitted in non-government aided colleges that have not been assessed and rated once, as well as in non-government aided, unaided, or permanently unaided colleges whose NAAC assessments and re-evaluations are currently inactive, starting from the commencement of first-year admissions for the academic year 2023-24.

It is mandatory for these institutions to submit the Institutional Information for Quality Assessment (IIQA) to the NAAC office by the specified date. According to sub-section 6(k) of section 109 of the Maharashtra Public University Act 2016, provisions have been made such that institutions failing to comply with state government conditions will not be recommended to the state government.

Furthermore, sub-section 4 of section 110 of the Maharashtra Public Universities Act 2016 stipulates that if a college or institute is eligible for and expected to receive accreditation or re-accreditation and fails to meet the necessary requirements, the provision allows for the withdrawal of any affiliation grants to such colleges or institutes.

Therefore, colleges that do not meet the terms and conditions for NAAC evaluation, grading, and re-evaluation by the commencement of first-year admissions for the academic year 2023-24 will face action, including the withdrawal of their affiliation, in accordance with the mentioned provisions of the Maharashtra Public University Act 2016.

We kindly request you to take appropriate action in accordance with the above information.

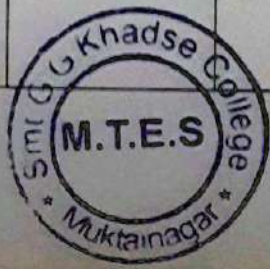
CHART OF THE RENEWAL/NATURAL GROWTH FOR THE ACADEMIC YEAR 2023-



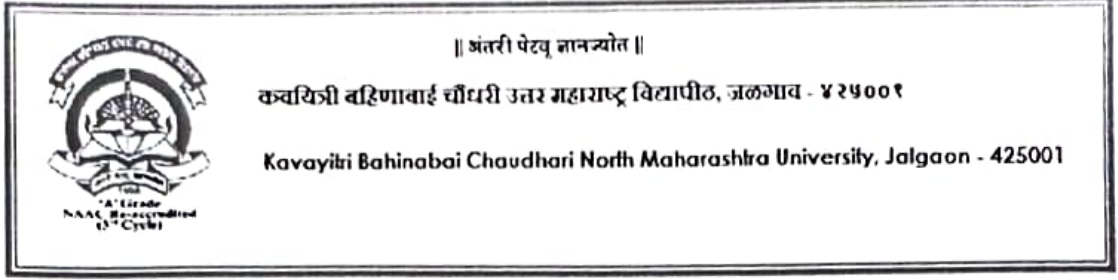

In light of this situation, as per the letter dated 04/04/2021, we requested information on 20 points. The information submitted by you and the received proposal were scrutinized by the board of trustees.

After thorough scrutiny and inspection by the board of trustees, the recommendations regarding the renewal of affiliation/natural expansion and student admission were included in the report sent to Hon. Chancellor for accreditation by the Vidya Parishad. Accordingly, the continuation of affiliation/natural growth for the courses mentioned in the accompanying table is approved under section 114(1) of the Maharashtra Public Universities Act, 2016, for the specified period.

We want to emphasize that the recognition granted to your college is valid for one academic year only, i.e., for the academic year 2021-2022. It is mandatory for you to renew this recognition periodically.

Colleges that do not fulfill the conditions related to the Principal, Librarian, Director of Physical Education, and 50% of teachers should fill these positions within 3 months by submitting a content letter of Rs.100/- on non-judicial stamp paper. The renewal of affiliation/natural growth for the academic year 2021-2022 is approved, including student admission.

However, only the renewal/natural growth of enrollment for the academic year 2021-2022 will be granted to colleges mentioned as "No admission for first year and/or second year directly" in the accompanying table. Such colleges should not admit students for the first year and should directly admit students for the second year. However, these colleges/institutions should pay Rs. 100/- along with documents to demonstrate their efforts to fill the vacant posts.

In cases where related matters of colleges are still pending in court, please note that further action will be taken based on the court's order.

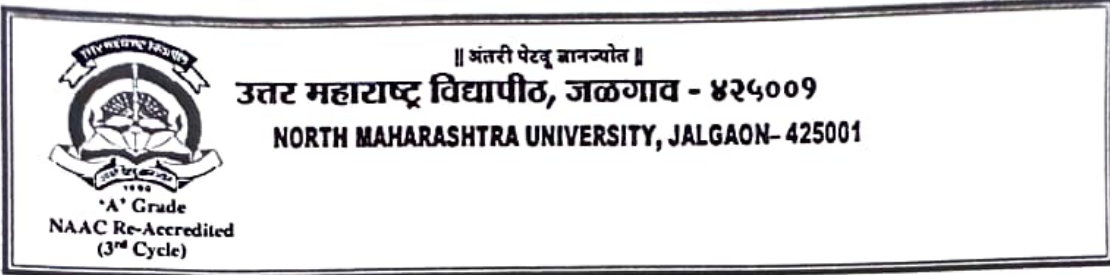
